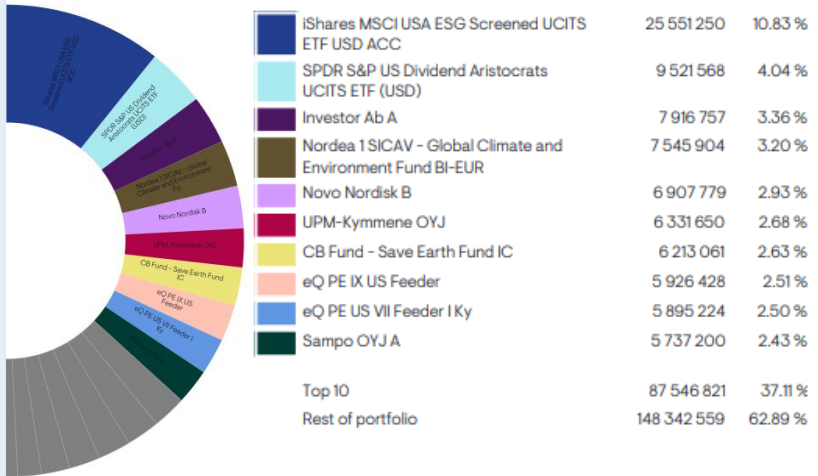

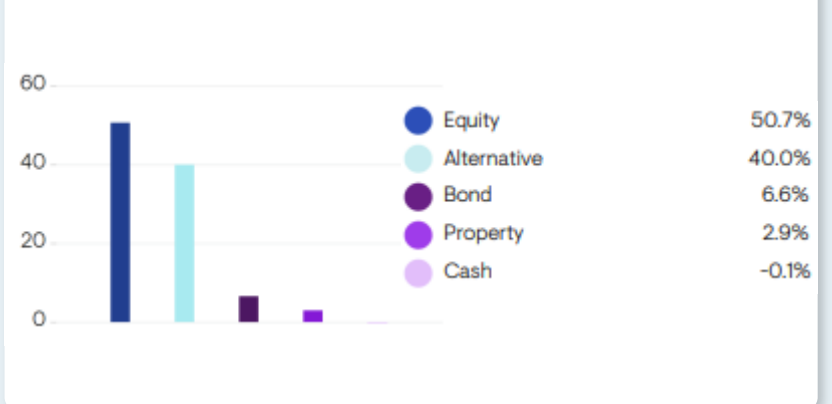

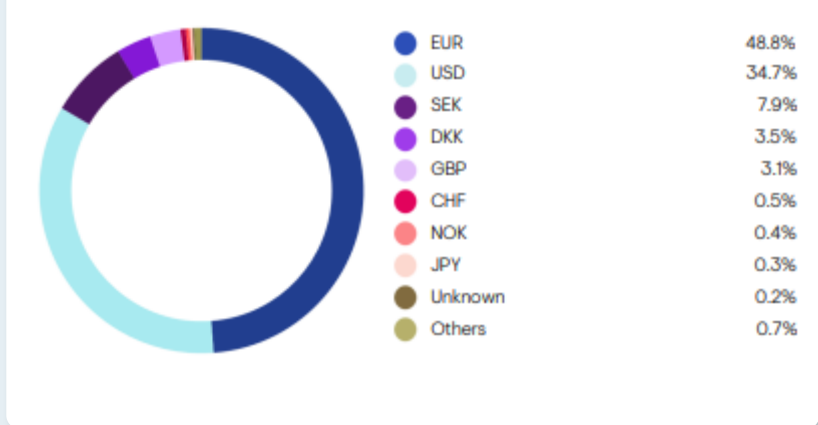

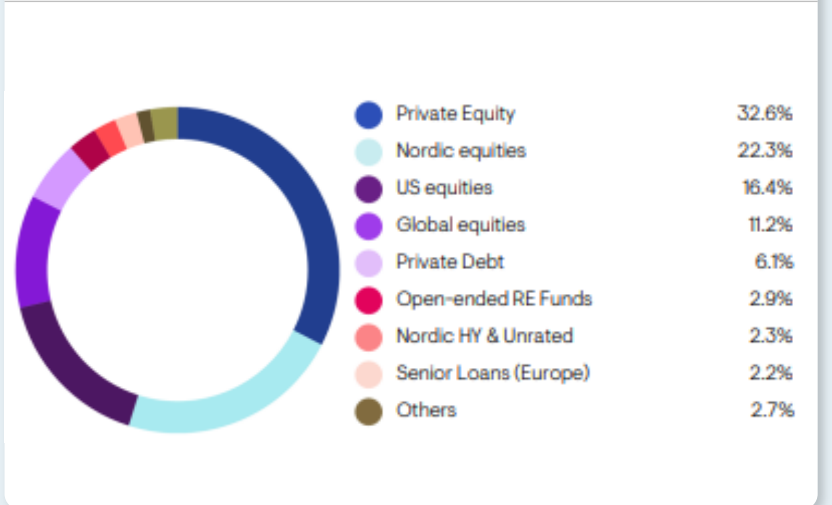
Asset allocation

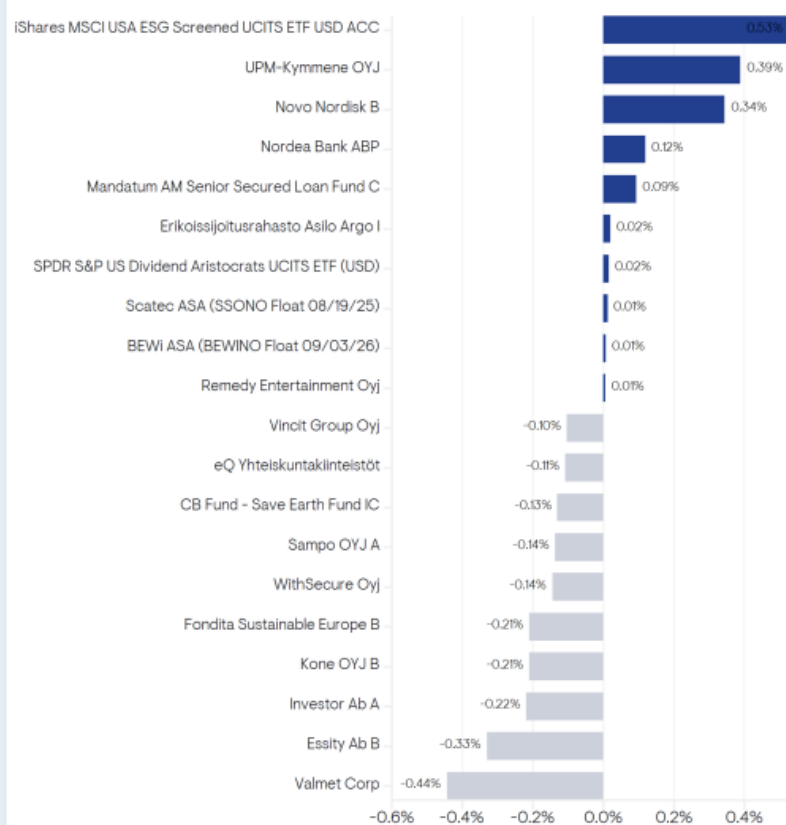
